These flexible RF cable assemblies are ideal for applications where flexure is required. Our L-com TRB 3-Slot to TRB 3-Lug cable assembly has a plug to jack gender configuration with 78 Ohm flexible 30-02001-LC series coax and operates to 400 MHz. The LC3MP2177 cable assembly consists of a 3-slot solder/clamp TRB plug to a 3-Lug TRB Solder/Clamp Jack for 30-02001-LC, that is a standard lab-rated PVC cable for MIL-STD-1553 applications. It features a larger diameter cable (0.242" O.D.)

Custom versions of this TRB 3-Slot plug to TRB 3-Slot jack cable, along with the rest of L-com's other RF assemblies, can also be built and shipped same day. Other available RF cable assembly value added services from L-com include connector orientation or clocking, heat shrink booting and custom labeling. 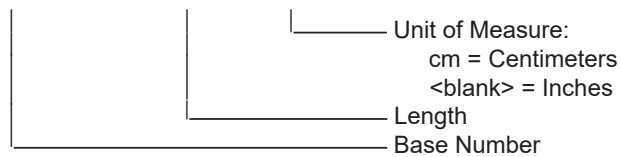

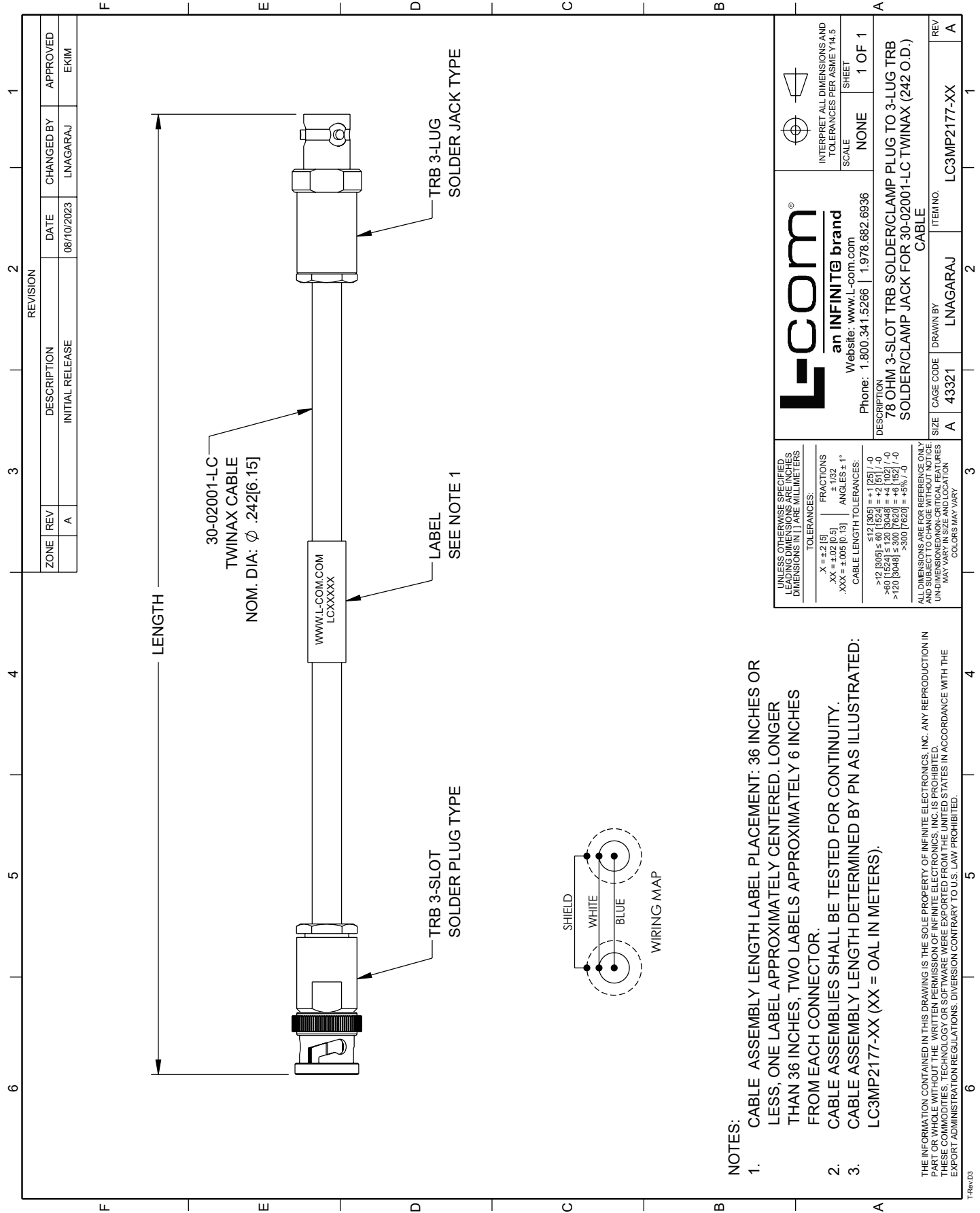
